**RECOMMENDATION**

The General Manager recommends that the Board of Directors authorize the appropriation of funds and the purchase of Global Navigation Satellite System (GNSS) survey equipment from California Surveying and Drafting Supply at a cost of \$75,000 to replace outdated equipment.

**BACKGROUND**

GNSS equipment is used by Design and Construction's Survey Crew to survey sites throughout the East Bay Regional Park District (Park District). The GNSS equipment to be purchased includes two Trimble R12i receivers with built-in radios and one external radio transmitter, plus rods and accessories. The Park District's current GNSS equipment is over ten years old and is no longer supported by the manufacturer in terms of warranty or replacement parts.

New GNSS equipment is available for purchase directly from California Surveying and Drafting Supply by means of pricing established by the State of California, Department of General Services, Procurement Division, Contract #1-21-66-03. The contract pricing is the result of a competitive bid process and open to all state and local governmental entities. Public agencies electing to use this method of equipment acquisition avoid the administrative costs of seeking formal bids.

**ANALYSIS**

The next generation GNSS equipment will allow improved survey access and accuracy under varying field conditions and over long distances, improve turnaround time for data collection and transfer, and streamline the surveying process.

**FISCAL IMPACT**

Funding for this purchase will be appropriated into the Major Equipment Replacement Fund 554-7324-000-7549.

**WHEREAS**, California Surveying and Drafting Supply is a recognized vendor offering suitable equipment based on the results of competitively bid pricing established by the State of California, Department of General Services, Procurement Division, Contract #1-21-66-03;

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Directors of the East Bay Regional Park District hereby authorizes the purchase of Global Navigation Satellite System survey equipment for a total cost of \$75,000 as presented to the Board on November 5, 2024; and

**BE IT FURTHER RESOLVED**, that \$75,000 will be appropriated from the Major Equipment Replacement Fund fund balance to 554-7324-000-7549; and

**BE IT FURTHER RESOLVED**, that the General Manager is hereby authorized and directed, on behalf of the Park District and in its name, to execute and deliver such documents and to do such acts as may be deemed necessary or appropriate to accomplish the intentions of this resolution.
