RECOMMENDATION

- **Authorization to Award Job Order Contracts JOC-037, and -038 to Grade Tech, Inc and Mark Scott Construction, Inc., respectively, with each contract for a one-year period, for a minimum contract value of \$50,000 and a maximum contract value of \$2,000,000.**

Job Order Contract Background

- **Alternative competitive procurement method to award annual contracts for capital projects for renovation, refurbishment, repairs, and remodeling projects.**
- **The District operates the JOC program consistent with Public Contract Code and by the District's JOC policy**

Job Order Contract Background Con't

- Like an on-call general contractor who will perform work according to an established set of unit prices with a competitively bid price factor applied.
- First round of contracts awarded in 2016
- Work to date: paving, roofing, building demos, sewer repair, building renovations, levee repairs, bridge repairs, pond repairs, dredging, landslide repair, fencing, building abatement, ADA improvements

Job Order Contract Bidding

District Staff has bid the next round of JOC contracts including:

- 2 “A” contracts for General Engineering

The contract terms and limits are a minimum offer of \$50,000 in work with a maximum limit of \$2,000,000 per contract.



Job Order Contract Bidding

The bidding process included the following:

- a) Working with the Gordian Group to create and update the construction task catalog and bid documents (the District's standard General Conditions and Level 3 agreement are primary to the bid documents),
- b) Publicly advertising the JOC contracts on the District website, online Plan Room, and in one industry publication,
- c) Hosting a mandatory pre-bid meeting that outlines Job Order Contracting and how it is utilized at the District,
- d) Publicly opening bids.
- e) Bids were opened on January 23, 2024 and staff recommends authorization to execute approval of two Job Order Contracting contracts based upon the lowest responsive, responsible bids.
