RECOMMENDATION

The General Manager recommends that the Board of Directors authorize execution of an Agreement for use with the City of Hayward Fire Department to utilize the Hayward Fire Department Training Center for East Bay Regional Park District Fire Department personnel fire training.

BACKGROUND

The East Bay Regional Park District (Park District) is committed to ensuring the safety and preparedness of its Fire Department employees. As part of the Fire Department's ongoing professional development initiatives and with the acquisition of new self-contained breathing apparatuses, the Fire Department is focusing on the California State Fire Training curriculum. Park District Fire Department personnel will be participating in the Fire Fighter Survival course at the Hayward Fire Department Training Center the week of November 18, 2024. This course is essential for enhancing the skills and knowledge of Park District Fire personnel, equipping them to handle emergencies effectively and ensuring their safety in hazardous situations.

The Agreement requires the Park District to indemnify the City of Hayward and to provide insurance.

ANALYSIS

The Hayward Fire Department Training Center is a state-of-the-art facility that specializes in fire service training. Its location is advantageous for our staff, allowing for easy access while reducing travel time and associated costs. The center is equipped with resources and trained personnel to deliver high-quality instruction on fire fighter survival techniques.

FISCAL IMPACT

The approximate cost for the training \$4,885 is included in the existing Fire Department budget in the Public Safety Division.
