Sustainable Purchasing Guide Cleaning Chemical Products



Use this Guide When Purchasing

- General/multi-purpose cleaners
- Glass cleaners
- Floor & carpet cleaners
- Non-disinfecting restroom cleaners
- Specialty cleaners such as: degreasers, dishwashing detergents, laundry detergent, wood & metal polishes, and drain cleaners

Keeping your facility clean is one of the most important ways to maintain a healthy indoor environment, but using some cleaning products may actually increase indoor air pollution. Using products that meet the Minimum Requirements below will, when properly used, not only meet performance requirements, but also reduce custodial workers' and occupants' exposure to harmful chemicals.



How to Purchase

Check with your central procurement office or administrative or facilities staff to find out if you have any contracts that employees are required to use to purchase cleaning products. When you are seeking these products in a store or online, check the product details to confirm it meets the Minimum Requirements listed below. If cleaning products are included in your custodial service contracts, require vendors to use products that meet the following Minimum Requirements as well.

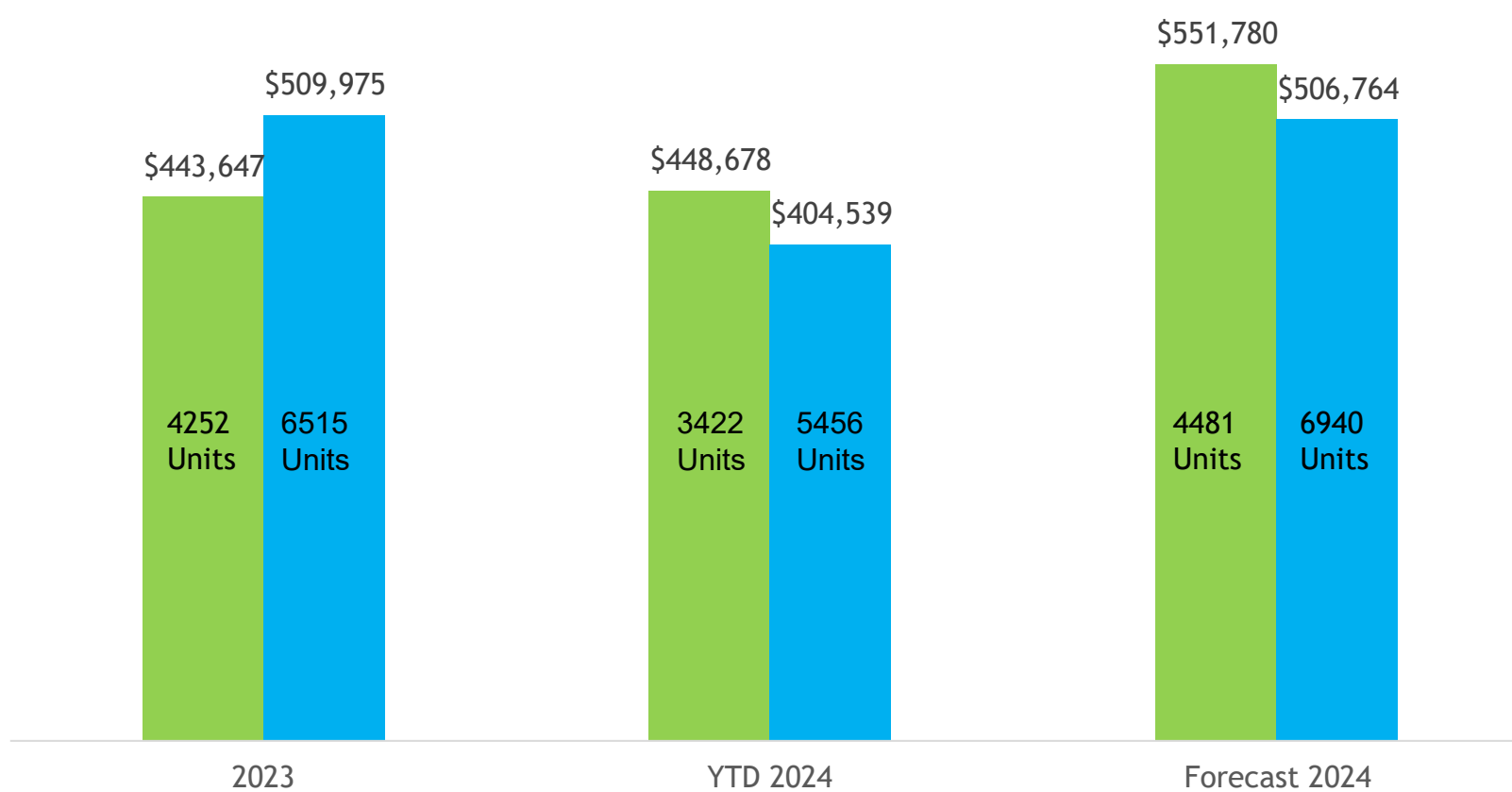
- Product currently has at least one of the following low-toxicity certifications:
 - Green Seal
 - Safer Choice
 - UL ECOLOGO

LEADERSHIP OPPORTUNITIES

Minimum Requirements plus one or more of the following:

- Concentrated products with a built-in or compatible closed-loop dilution control system
- Fragrance-free
- USDA Biobased certified
- Non-aerosol
- Not a single-use disposable wipe product
- Packaging is recyclable in your municipal system
