

UPDATE ON BOARD INDIVIDUAL BOARD MEMBER INTERESTS

October 1, 2024

This is an update on the status of the priorities and interests shared by the Board of Directors at their Study Session on June 7, 2024, to inform development of the 2025 budget. The following table includes four columns, outlined below:

- **Board Request:** Outlines the individual priorities shared by Board members at the June 7, 2024 Study Session.
- **Update:** Provides a summary update on the status of each stated interest as of September 2024.
- **Lead Division:** Specifies the Division responsible for leading the item. Divisions listed include Acquisition, Stewardship, and Development (ASD), General Manager's Office (GM'S OFFICE), Finance & Management Services (FMS), Human Resources (HR), Operations (OPS), Public Affairs (PA), and Public Safety (PS).
- **Status:** Outlines whether an item is:
 - **Ongoing:** Policies or programs that continue year after year and receive annual budget allocations.
 - **In Progress:** Items that require additional effort before becoming an ongoing program or policy, or a project in the planning or construction stage that is not yet complete.
 - **On Hold:** Items that have made progress but have been stalled due to circumstances outside of the Park District's control or require additional funding before resuming progress.
 - **Not on a Work Plan:** Items not on a current work plan but may be included on a future work plan pending further analysis.

The Board interests are organized in the table below by the following categories:

- **Budget:** Items related to funding and staffing.
- **Land Acquisition:** Items requiring acquisition of land.
- **Policy:** Objectives related to advocacy and internal policy development.
- **Program:** Ongoing programs including workforce development, outreach and education, and ongoing implementation of established Park District policies.
- **Project:** Discrete projects, which are primarily capital projects costing more than \$100,000, including trail connections, restoration, and development of parks and facilities.

Within each category, Board interests are organized by status and then alphabetically by Division.

1	<p>Continue to pursue grant funding</p>	<p>The General Manager’s Office continues to advocate at the state and federal level to create key funding opportunities, including managing a legislative program framework through the Government & Legislative Affairs team. The Grants Department works with staff throughout the Park District to proactively plan for and pursue funding strategies for priority programs and projects. On average, the Grants Department submits approximately 35 grant applications each year. As of September 2024, the Grants Department has submitted 25 applications and anticipates submitting 15 more. The Grants Department is currently monitoring approximately 170 applied, awarded, and active grants totaling nearly \$193.5mil. The Grants Department also manages the public assistance funding from FEMA/CalOES for winter storm damage projects that occurred in 2017 and 2023.</p> <p>30x30 grant highlights in 2024 include \$4.6 mil awarded:</p> <ul style="list-style-type: none"> • \$2.6 million grant from Wildlife Conservation Board for the Tidewater Day Use Area Expansion project • \$2 million grant from CA Coastal Conservancy for fuels reduction work District-wide <p>The Government and Legislative Affairs team continues to work toward creating new and ongoing grant opportunities, as well as seeking direct budget allocations at the state and Federal levels. In 2023, \$5.5 million in direct state funding was allocated for Roddy Ranch / Deer Vally Park development and the Wildcat Creek Brook Road project in Tilden. Also in 2023, \$2.2 million in direct Federal funding was allocated for wildfire mitigation at Anthony Chabot Regional Park and the Martinez Bay Trail Gap Closure. During the 2024 state budget cycle, it became clear the legislature needed to explore alternative funding mechanisms to support important projects previously funded by the General Fund and distributed to the Resources Agency (CAL FIRE, State Coastal Conservancy, Wildlife Conservation Board, etc.) In order to enable these agencies to continue funding ongoing resources related work, the legislature passed at \$10 billion climate bond to appear on the November 2024 ballot. The Park District has historically competed effectively for at least \$1.9 billion of the allocations to state agencies included in the bond. Government and Legislative Affairs staff were active participants in the Clean Water, Natural Resources and Parks coalition as well as TOGETHER Bay Area, which successfully advocated for significant funding for the three agencies highlighted above.</p>	<p style="text-align: center;">GM’S OFFICE/ FMS</p>	<p style="text-align: center;">Ongoing</p>

2	Ensure long term fiscal sustainability through parcel tax ballot measure	The Park District last administered a scientific voter survey regarding a parcel tax ballot measure in April 2024. This survey of likely November 2024 voters was conducted by Tulchin Research and fielded from April 9-16, 2024. In this survey, respondents were asked their willingness to support at \$24 per year parcel tax. Rooted in a variety of reasons, the support for this tax was lower than expected at 52% without lean votes and 61% with. Both are under the required 2/3 support needed for such a measure. It is notable voters are more pessimistic (-25 right-wrong track) since previous polling research (-7 right-wrong track) in this region (Feb 2023). Crosstabs for the results of this survey are still being analyzed, but there is consensus to maintain existing park and trail infrastructure. There is also an awareness extreme weather events are impacting the Park District's ability to maintain parks and trails. The Park District's next voter survey is planned for the fall of 2024. 3	Create Volunteer Coordinator position and continue to expand Volunteer program	The Park District's Volunteer Program Supervisor position historically oversaw the Park Express bus transportation team and the Volunteer Program team. In the 2024 Operating Budget a Transportation Supervisor position was added to create more capacity so both programs would have adequate staffing and oversight. With the Volunteer Program Supervisor position just focused on Volunteer Programming, a cross divisional working group will be evaluating the Park District volunteer program to make recommendations to better align the program with best practices to serve both the Park District and provide opportunities for the public. 		Staff is currently pursuing multiple efforts to address mountain bike access. 14	Implement Environmentally Sustainable Policies Throughout District	<p>On March 21, 2023, the Boad of Directors approved substantial amendments to the Environmentally Preferred Purchasing Policy, including changing the name to the Environmentally Sustainable Purchasing Policy. The Policy, which encourages environmental responsibility in purchasing decisions, was updated to reflect current practices and incorporate new Park District policies and practices. The updated Policy was developed through an inter-divisional effort led by Finance & Management Services to create a more user-friendly policy and ensure implementation. It directs purchasers to use StopWaste’s Sustainable Purchasing Guides, which will be updated over time as products, certifications, and recommendations evolve. Management Services will report on green purchasing to the Finance Committee in October.</p> <p>Training has been added to the New Employee Orientation and the Park District’s Summit training portal. In- person Training has been provided at LEAF Cohort #2, Central Stores Advisory Committee, Ops and Clerical Forum, Operations Managers, and Finance and Management Services staff meetings. Staff will continue to provide training for upcoming LEAF Cohorts and Division meetings. Central Stores has prioritized transitioning to providing green alternative products. For 2023, 37% of sales were for green products. The Central Stores Advisory Committee continues to test new green products for possible addition to inventory.</p> <p>To give members of the public the opportunity to divert waste from the landfill, the Park District is installing 100 additional three stream BearSaver bins in the parks in each year at priority locations such as picnic areas, with the goal of eventually providing three stream recycling at every location. These bins provide expanded recycling opportunities and compost collection. Staff have initiated a new pilot program with three stream bins that have wheeled waste carts inside to eliminate the need for bag liners and support efficient collection. To ensure the Park District can proactively meet these needs, it requires a strategic IT plan to guide the effective management, prioritization, and resource investment.</p> <p>The Park District engaged with ClientFirst, a consulting organization specializing in this domain, to assess the current state of hardware, software, infrastructure, applications, resources, and security, and provide recommendations for future technology needs. Staff throughout the Park District were engaged in the process to understand current processes and needs. The plan included a summary of findings, prioritized recommendations, supporting documentation and a project plan outlining projects by priority, including timelines and cost estimates.</p> <p>The ongoing goal of the project is to align technology with the Park District's strategies and goals, identify and budget for project initiatives to improve constituent services, increase division operational efficiency, reduce risk, and improve cybersecurity posture. An overview of the plan will be presented to the Board of Directors this fall.</p> <p>In the meantime, the Park District has focused on rolling out infrastructure improvements to our network, and priority software for business needs, including a new streaming services and agenda management software for public meetings, assessing our ERP system, and improving remote support capabilities. Staff continues to look for ways to modernize practices and utilize data in alignment with the new IT Strategic Plan.</p>

18	Continue leadership in wildfire mitigation and prevention	<p>Wildfire prevention work, as described in the Wildfire Hazard Reduction and Resource Management Plan, includes but is not limited to vegetation and fuels management work to reduce the risk of wildfire on properties in high-fire danger areas and areas closest to the wildland-urban interface through hand-labor removal, prescribed burns, mechanical treatment, tree thinning, weed eating, and prescribed animal grazing. Recent budget increases have boosted capacity for fuels management by expanding crews and hiring additional staff. Also, a consultant has completed our California Vegetation Treatment Program (Ca VTP) to obtain permits for wildfire prevention work outside of the current EIR, which was adopted by the Board in 2023</p> <p>The Fire Department has assessed and prioritized all areas with tree dieback. The Fire Department has obtained \$12 million in funding through the work of Government and Legislative Affairs. This includes contributions from State Senators Nancy Skinner and Bob Wieckowski, U.S. Senator Alex Padilla, and U.S. Representative Eric Swalwell. The Grants Department has also secured an additional \$2.8 million through a collaborative grant with Calfire, the East Bay Municipal Utility District, U.C. Berkeley, and the Berkeley Fire Department. Furthermore, \$2 million has been granted by the California State Coastal Conservancy for the department's fuels projects. Fuels work has been completed at Miller Knox, Tilden, Redwood, Sobrante Ridge, Lake Chabot Regional Park, Anthony Chabot, Claremont Canyon, Carquinez Strait, Sibley Volcanic, and Kennedy Grove.</p> <p>The new Carbonator processed 12,200 tons of logs at Anthony Chabot as of the fall of 2024. The Fire Department has completed 475 acres at Anthony Chabot and has begun the Continuation Project for another 221 acres. The Fire Department continues to utilize the Carbonator to process biomass sustainably. The Continuation Project costs</p>	ALL	Ongoing

		<p>\$5.3 million, with funding being provided by various funds, including the State, FEMA, and the Park District general funds. This project aims to thin existing dead trees to reduce wildfire risk.</p> <p>In partnership with CAL FIRE, the Park District has completed the fine-scale vegetation and wildfire prevention maps to identify high-fire hazard areas in Alameda and Contra Costa Counties that will assist in wildfire prevention planning. 19	Continue to facilitate legislative site visits	<p>The General Manager’s Office continues to lead legislative site visits to engage elected officials, staff and agency colleagues on the Park District’s legislative priorities through the Government & Legislative Affairs team. In 2024, six events were hosted engaging 14 elected offices and 8 partner agencies. These site visits included three elected office staff site visits held at: Briones Regional Park, Tidewater Boating Center, and Judge John Sutter Regional Shoreline. Engaged elected offices include both Federal Senate offices, four congressional offices, one state Senate, four Assembly and three county supervisors. Additional site visits were conducted with California Natural Resources Agency Deputy Secretary for Forest and Wildfire Resilience Lisa Lien-Mager to see the carbonizer at Anthony Chabot Regional Park and with several stakeholders at the Roddy Ranch site in June and August. The June site visit included staff from State Senator Steve Glazer’s Office. In August, staff from the Wildlife Conservation Board and State Coastal Conservancy visited the site. Planning is under way for four elected office staff site visits in 2025 plus additional site visits and special events as needed.</p> <p>Walk and talks were not hosted in 2024. 20	Implement and Expand the Local Government Program	<p>By adopting Board Resolution No. 2024-05-088 on May 7, 2024, the Board of Directors advanced the 2024-2025 Local Government Engagement Strategy Pilot Program. The pilot program seeks to address the need for consistent and coordinated engagement with all East Bay local elected officials, defined as local city, county, and special district agencies. The pilot program to increase local and regional elected official engagement is supported by the Government and Legislative Affairs team to provide for consistent and coordinated meeting facilitation between the Park District Board of Directors and local elected officials. 		<p>program will be organized into a comprehensive report to be shared with the Second Century District Plan planning team for integration, as well as the Board of Directors, General Manager, and staff Executive Team for awareness. The initial meeting occurred on August 30, 2024, between Park District Directors Echols and Rosario, and General Manager Landreth with East Bay Municipal Utilities District Director Katz and General Manager Chan. The Government and Legislative Affairs team will be onboarding additional support for the program with a Legislative Assistant beginning in October 2024 to further facilitate meetings between Board Members and local elected officials. By advancing this work through a formalized pilot strategy, there is opportunity for review and refinement prior to finalizing a formal local government program within the Park District. Following the implementation of this program, a formal report will be provided on the insights and outcomes in early 2026.</p>		
21	Continue to prioritize workforce development	<p>The Park District is committed to filling all its vacancies and creatively recruiting for Public Safety Police and Fire positions. As of September 1, 2024, the Park District's vacancy rate is 8.1% which is well below neighboring agencies that continue to struggle to fill vacancies at all levels. The Recruitment Team attends training sessions and works with the Office of Equity to keep apprised on new trends and outreach opportunities to ensure that the Division incorporates essential DEI practices. Human Resources also meets regularly with command staff in Public Safety, AFSCME Local 2428 and the Police Association to collaborate on recruitment efforts as well as participate in career fairs. In 2024, Human Resources implemented a new Military Leave Policy and revised Family Medical Leave and Background Checks policy.</p>	HR	Ongoing

27	Enhance external communications and participation in community activities	Public Affairs continues its robust external communications via the Regional in Nature (RIN), Park Explorer e-News (56,000+ subscribers), news releases, social media, and collaboration with other divisions and units to enhance external communications and community engagement. Efforts to grow these communications lists, including to retirees, will happen in 2025. Major initiatives continue to be prioritized along with other divisions and include communications expertise and support for the Second Century District Plan, Habitat Conservation Plan, Tilden Environmental Education Center (EEC) project and ongoing communications for the Briones Pilot Project, among others. Some legacy events, like multicultural walks and other programs have been transitioned to the I&R division and staff is evaluating them for relevance to mission. Public Affairs staff continues to recruit and engage volunteer Ambassadors for tabling events in the community with the goal of building up volunteer engagement in 2025 to match pre-COVID levels to support outreach. Public Affairs has established a strong relationship with the Office of Equity in an effort to diversify stakeholder engagement, including the New Voices Partnership, and other efforts. Park District staff and the Creative Design Group developed and installed Native American names into trail posts at Coyote Hills in November 2022, completing the work to rename 35 trail posts to include trail names in the Chochoyeno language. The Office of Equity will be supporting in a review and re-development of the Land Acknowledgement used at Board Meetings. This all aligns with an internal effort to develop a “Tribal Engagement Framework” to help orient, frame, and guide the emergent and necessary work of more intentional engagement with the region’s Native communities impacted by Park District decisions.</p> <p>Additionally, Public Affairs works to celebrate and promote heritage months via the website and social media. It produces pins for staff and Board for heritage and celebration months. Recognition of indigenous peoples is part of the development of the Strategic Plan. Supporting this, Public Affairs is also collaborating with Interp & Rec and the Office of Equity on the development of a clearer and more standardized process for Heritage Month and Special Observance designations.</p> <p>The Park District will review its Naming Policy and recognition of indigenous peoples through development of a new Master Plan. 30	Continue to ensure park user safety	<p>The Police Department has been undergoing major efforts to increase Public Safety staffing through partnerships with Human Resources, which will in-turn result in shorter response times and higher levels of enforcement. The Police Department meets monthly with Stewardship staff and each Park Unit to discuss trends, emerging issues, and factors that create threats to the safety of our public. Those issues are entered into CAD (Computer Aided Dispatching) as Patrol Priorities that generate requests for specific and plentiful saturation of patrol checks and directed patrol efforts. This protocol has led to priority issue mitigation with just a call or email when time is of the essence. Officers and some Commanders attend monthly Volunteer Trail Safety Patrol (VTSP) meetings to discuss issues and priorities. The VTSP sets up regular information booths along high use trails to educate park users about Ordinance 38. Implementation of Citizen RIMS, the new system used by Police and Fire to provide information about police and fire activity more accessible to the public through an interactive webpage with near real-time mapping of police and fire activity, including location, date and time, a general description, and outcome, began on August 1. The new system also allows the public to sign up for daily or weekly email updates with a summary of public safety activity and links to more information.</p> <p>The Park District utilizes the best practices of environmental design and Public Safety is engaged in the facility design process to maximize safety for the public. The Park District utilizes appropriate trail design standards to provide for appropriate site lines, reasonable grades, and incorporate features to minimize potential for user conflict through the trail design process. The Business Services Residence Program, which works in conjunction with Trades, works to ensure timely turnover of security residences to maintain a security presence within parks.</p>	PS/OPS/ ASD	Ongoing
