RECOMMENDATION

The General Manager recommends that the Board of Directors authorize the appropriation and transfer of \$75,000 of Measure FF funding into Enhance Pallid Manzanita Project (Project) (Project No. 562300) for Sobrante Ridge Regional Park (Sobrante Ridge).

BACKGROUND

Sobrante Ridge Regional Preserve harbors one of the two reproducing populations of the state and federally endangered pallid manzanita in the Park District. Through the Measure FF project development process, management of the pallid manzanita population was identified as a high priority and funding was allocated for protection and management. To properly manage this population, management actions must be taken to improve habitat conditions and recruitment potential for the long-term sustainability of the population. The pallid manzanita populations at Sobrante Ridge are threatened by overtopping of encroaching trees, nonnative plant competition, and low regeneration. This project will implement a management plan, which is currently in development, for the pallid manzanita population at Sobrante Ridge.

ANALYSIS

Measure FF funding was designated for management of the population of endangered pallid manzanita at Sobrante Ridge. This action will appropriate funds to implement the Pallid Manzanita Management Plan, including establishing a monitoring program and actively managing the grove for long-term population viability.

FISCAL IMPACT

This action will appropriate the entire balance (\$75,000) of the available in Measure FF Sobrante Ridge Resource Related Allocation Area Fund (FR20) into the Project. The funds will be used to implement some key recommendations in the management plan. The Project budget funds do not cover the total cost to implement restoration as outlined in the management plan, and additional funds will be needed to implement all guidance in the management plan, and for ongoing maintenance of the area in addition to staff time.

WHEREAS, Pallid manzanita populations at Sobrante Ridge are at risk from being overtopped by other trees, nonnative plant competition and low regeneration; and

WHEREAS, development and implementation of a management plan is necessary, and funding is needed; and

WHEREAS, Measure FF funds are available and slated for this project from the Sobrante Ridge Resource Related Allocation Area;

NOW, THEREFORE BE IT RESOLVED, that the Board of Directors of the East Bay Regional Park District hereby authorizes the appropriation and transfer of \$75,000 from Measure FF Sobrante Ridge Resource Related Allocation Area Fund (FR20) into the Enhance Pallid Manzanita Project (Project No. 562300) for Sobrante Ridge Regional Park as presented to the Board on March 5, 2024; and

BE IT FURTHER RESOLVED, that the General Manager is hereby authorized and directed, on behalf of the Park District and in its name, to execute and deliver such documents and to do such acts as may be deemed necessary or appropriate to accomplish the intentions of this resolution.
