- d. Authorization to Execute Agreement in the Amount of \$67,807 with Ojo Technology for Installation of a Security Camera System: Cull Canyon Regional Recreation Area (Sykes/Castile)

RECOMMENDATION

The General Manager recommends that the Board of Directors authorize the expenditure of funds for an agreement with Ojo Technology to purchase and install a security camera system at the lagoon area of Cull Canyon Regional Recreation Area.

REVENUE/COST

The cost to furnish, install, and configure three (3) security cameras is \$67,807. Funding is available in the Recreation Areas Unit Manager budget, Account No.101-5130-239-6444 (Maintenance Agreements).

BACKGROUND

The East Bay Regional Park District (Park District) will install a safety/ security camera system to assist Public Safety and Park Staff in managing the safe use of the Cull Canyon Lagoon swim areas. The cameras will be focused on the lagoon area and be able to retain vital video data which may be reviewed if an aquatic incident has occurred.

In consultation among the Park Operations, Public Safety, and Information Services Departments, the Ojo camera system was determined to be the best system for the swim lagoon monitoring. An Ojo camera system was installed and has been in use at the Roberts Recreation Area since 2008. The system has performed exceptionally with good customer support and video quality. Their proven performance and service will continue to provide safety and have uniform hardware and software for the camera systems.

The agreement includes furnishing, installing, configuring, and testing three (3) Hanwha PNM-9085RQZI, 20MP multi-imager IP Network Dome Cameras with associated hardware and wiring. The configuration will include programming to the Park District and the testing will include verification of recording to the recording server.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the East Bay Regional Park District hereby authorizes the execution of an agreement in the amount of \$67,807 with Ojo Technology for installation of a security camera system at Cull Canyon Regional Recreation Area, and

BE IT FURTHER RESOLVED that the funding in the amount of \$67,807 is available in Account No. 101-5130-239-6444 (Recreation Areas Unit Manager-Maintenance Agreements), and

BE IT FURTHER RESOLVED that the General Manager is hereby authorized and directed, on behalf of the Park District and in its name, to revise and amend such documents and to do such acts as may be deemed necessary or appropriate to accomplish the intentions of this resolution.
