**RECOMMENDATION**

The General Manager recommends that the Board of Directors authorize the execution of a \$127,142 contract with Frontier Resource Management, LLC to conduct a forest inventory suitable to inform the development of a Redwood Forest Management Plan that will support and enhance the health of the East Bay Redwoods.

**BACKGROUND**

In November 2018, western Alameda and Contra Costa County voters approved Measure FF, supporting a commitment to fund projects promoting healthy forests and preservation/restoration of natural habitat. Funds were assigned for projects in the two parks containing historic redwood forests, Roberts Regional Recreation Area (Roberts) and Dr. Aurelia Reinhardt Redwood Regional Park (Reinhardt). In fulfillment of that commitment, the East Bay Regional Park District (Park District) is taking the first step to develop a Redwood Forest Management Plan by gathering baseline data on the redwood forest.

The East Bay redwood forest is the easternmost population of extant redwoods. While relatively isolated, it offers a unique opportunity to preserve and enhance an iconic ecosystem and provide sustainable recreation. Redwoods are iconic, one of the longest living organisms, and redwood forest communities are an important focus of conservation efforts and offer opportunities for carbon storage and other climate adaptation benefits.

**ANALYSIS**

On September 13, 2024, the Park District released a Request for Proposals (RFP) to conduct a forest inventory and develop a Redwood Forest Management Plan. Preliminary goals of the plan include improving forest health, improving stream health, and improving habitat for native species. The RFP was open for 37 days and four (4) firms responded. A review panel, including reviewers from

Stewardship, Fire, and Operations, carefully considered the proposals and ultimately selected Frontier Resource Management's proposal for a total cost of \$127,142 as having the best qualifications and approach and as the most cost-effective proposal.

### **FISCAL IMPACT**

The consultant costs to provide a forest inventory is \$127,142. Funds from Measure FF are available in the Assess Redwoods and Management Plan Project (No. 563600). The table below shows the source of funds and the available balance remaining after this action if approved by the Board of Directors.

**WHEREAS**, four consultants responded to the RFP, and the review team determined that Frontier Resource Management provided the most cost-effective and qualified proposal;

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Directors of the East Bay Regional Park District hereby authorize executing a contract with Frontier Resource Management LLC in the amount of \$127,142 as presented to the Board on December 17, 2024; and

**BE IT FURTHER RESOLVED**, that the General Manager is hereby authorized and directed, on behalf of the Park District and in its name, to execute and deliver such documents and to do such acts as may be deemed necessary or appropriate to accomplish the intentions of this resolution.
