RECOMMENDATION

The General Manager recommends that the Board of Directors authorize the use of funds within the 2025 Adopted budget to approve the execution of a contract for services with Golden State Fleet services in the amount up to \$81,685, for \$6,685 in costs that exceeded \$50,000 in 2024 and up to \$75,000 in 2025.

BACKGROUND

The East Bay Regional Park District (Park District) has utilized Golden State Fleet Services since 2013 for almost all tow services and evidence vehicle storage services. This includes cars, trucks and mobile homes abandoned on Park District land, Park District vehicles that have broken down, and vehicles that are held as evidence in ongoing crime cases.

In 2024, Golden State Fleet Services' storage fees increased from \$15 to \$35 per day, greatly increasing the amount of monthly invoices charged to the Public Safety Department. Currently there are six vehicles being held in storage. In addition, all other tow jobs cost between \$150-450 in each instance. These costs are currently covered by the Public Safety Department and the Equipment Maintenance Department.

ANALYSIS

The Park District intends to issue a Request for Proposal (RFP) for these services in April with a recommendation for award to the Board of Directors in June, however we will need to maintain a contract with Golden State Fleet Services until we have completed the procurement process. Based on current invoices and projected costs there is an immediate need to execute a contract with Golden State Fleet Services for up to \$75,000 for Public Safety and Equipment Maintenance Departments for 2025. In addition, the Public Safety Department requests authorization to spend \$6,685 in costs incurred over \$50,000 in 2024.

FISCAL IMPACT

Sufficient funding is available in the Public Safety Detective Unit's and Equipment Maintenance's 2025 Adopted Operating Budget.
